General Criteria for Elders at Deer Creek Shores Presbyterian Church

- Commitment to Christ, the church, and its mission
- Faithful participation in Services of Worship
- Active participation in church activities during a person's membership at or involvement within the congregation
- Leadership in the life of the church
- A desire to lead
- A commitment to understanding and following Presbyterian government
- Evidence of continuing financial commitment to the church and its mission
- Ability and availability to complete tasks and fulfill responsibilities with a positive attitude on a regular basis
- Willingness to listen to other viewpoints and ability to be a peacemaker of the church
- Willingness to accept change but not pursue change just for the sake of changing
- Spouses / immediate family members cannot serve as Elders at the same time

Elders: (*Book of Order*, G-2.0301) "... congregations should elect persons of wisdom and maturity of faith, having demonstrated skills in leadership and being compassionate in spirit. Ruling elders are ... chosen by the congregation to discern and measure its fidelity to the Word of God, and to strengthen and nurture its faith and life. Ruling elders, together with teaching elders, exercise leadership, government, spiritual discernment, and discipline and have responsibilities for the life of a congregation as well as the whole church, including ecumenical relationships." (*Book of Order:* G-2014A) "Their manner of life should be a demonstration of the Christian gospel in the church and in the world.

In our congregation, each Elder serves on one of the Session Committees: Administration, Building & Grounds, Christian Education, Christian Life, Finance, Missions, or Worship.
